1. Call to Order

- 2. Additions, Corrections, and Approval of Minutes of the February 2, 2015 The Chair called for corrections, additions to the minutes; hearing none, a vote was called to approve the minutes; the minutes were approved.
- 3. Announcements and Reports by the Chair –The Chair reported on changes recently discussed with regard to General Education requirements. The first change pertained to providing support for whatever Gen. Ed. changes there will be, while the second looked at the goals and objectives. The second was tabled. The next vote will be delayed until after the next meeting. The Chair provided information (via overhead slide) on the proposed modifications to the current baccalaureate general education program. Some of the changes were already made and reviewed. All of these changes will be discussed at the next Senate meeting at University Park. Also integrated as part of the changes are the I-Courses, as this was originally part of one of the models that existed back in the summer concerning changes in Gen. Ed., creating several inter-domain or interdisciplinary courses. If a course covers two or more domains, this course would be registered as an I-Course. Students will be required to take some of these types of courses. Copy of this draft will be sent out to the list-serv for review and feedback is encouraged.

5. Comments and Announcements by Administrators

• Chancellor Hillkirk

- We have had a number of visits to Penn State Berks recently. Provost Jones and others from University Park were here a few weeks ago. The effort that has been made by both President Baron and the Provost in getting out to the campuses over the past year is commendable.
- Penn State Berks has a very strong presence in the community. Many of our faculty, staff and students make Penn State Berks proud in the many ways we serve the community. This is a very important part of our student's education. Last week, several of us, along with administrators from the Reading School District and from Glenside Elementary School, were in Atlanta to present a paper at the National Professional Development School Conference. The

quality of the relationship that has developed between us and Glenside Elementary and the Reading School District was very impressive. Reading School District has been challenged in a number of ways. Penn State Berks is doing very important work there. The district has asked us to look at ways in which to expand upon the work that is currently being done. All is very positive. The key for us is educating our students. Part of that preparation can include internships and other kinds of engagement within the community. This needs to continue to grow.

- Since the recent St. Joseph's acquisition to Penn State Hershey, a number of meetings have taken place. Penn State Berks is currently working closely with St. Joseph's in several key areas. We are about to submit a proposal jointly with them for some CEED funding to help us develop a presence for Penn State at their downtown location. This proposal will open up many opportunities for Penn State Berks and for our students through internships. More will be shared as this develops.
- Next Tuesday, March 24, a group will be visiting Penn State Berks to talk about the Penn State Values. This meeting will be town hall meeting beginning at noon in the Multi-Purpose Room. If you are interested in attending, registration is required.
- Beginning this spring, Penn State Berks will host two commencement ceremonies. The first ceremony will be held at 10 AM and the second at 2 PM. This change was prompted by our continued growth and the challenges faced during last spring commencement. The morning commencement will be for our EBC graduates and the afternoon commencement will be for HASS and SCI graduates. Rather than having a faculty breakfast, we will have a lunch. Faculty is welcome to participate in both ceremonies. In the morning, there will be a breakfast reception prior to commencement for graduates and their guests as well as faculty and staff. In addition to the faculty lunch, lunch will also be available for staff and students working both events. There will be a reception following the afternoon commencement ceremony for graduates, guests, faculty and staff. More details will be shared. Instructional letters to the degree candidates will be mailed today. The involvement with the Division Heads and their assistants, who have joined in the planning process, is much appreciated. Keeping all lines of communication clear and concise will be of the upmost importance.

Associate Dean Esqueda

As a review from the recent Provost visit, four points were highlighted with regard to the Strategic Plan: (1) The push university-wide and how all the units and colleges are being asked to provide a shorted version of the Strategic Plan; all were asked to consolidate their plans down to 15-20 pages. (2) The Provost mentioned one of the biggest issues facing the University concerns IT; there needs to be more control among all the units in order to provide security. Two audits have taken place including one from the federal government; much vulnerability has been identified. It will be necessary to go to a two-phase identification process in the near future in order to address this issue and given the number of units Penn State has, the oversight will need to be done centrally. (3) The state of the University is fabulous based on meetings with the rating agencies; we are receiving the same rating this year, so the University is doing very well. (4) Changes proposed with regard to the common class schedule and the need for all to have the same class schedule university-wide. This change is being made primarily so students can take advantage of any classes being offered throughout the University. Two primary reasons were mentioned as to why this is being done: (1) students would have a wide range of opportunities, particularly with on-line courses; and (2) it would open up competition. A handout from the Provost was distributed, which included on the reverse side, a mock-up common class meeting schedule. This has been ongoing for the past year and was presented to the Administrative Council on Undergraduate Education (ACUE); it was also presented at the University Senate and discussed at the Berks Senate. The overall consensus throughout the University was positive. Only two campuses opposed the policy; they are Penn State Altoona and Penn State Berks. Many of the issues surrounding the concerns at Berks have to do with the lack of classroom space. After much discussion with faculty and with the Senate, a decision was made by the Provost to enforce this new policy. There is no clear date as to when this new

policy will go into effect; however, fall of 2016 is anticipated. The floor was turned over to Penn State Berks Registrar, Dr. David Bender, who outlined some of the major changes for Penn State Berks with regard to this new schedule. A concern was made pertaining to the lack of debate afforded with regard to this policy, how changing this is a curricular matter, and in by doing so, how it will affect our curriculum overall. The Chair expressed that neither the University nor the Berks Senate would have the power to change this as this is an administrative decision; however, it does not prohibit the Senate from expressing an opinion. The Chancellor remarked that concerns were brought forth by both Dr. Bender and Penn State Berks administration throughout the process. A question was made if this new schedule also applied for the summer semester. Clarification was provided that this new policy only applies to fall and spring semesters. Several additional concerns were discussed. The Chancellor remarked that this change can create opportunities for us to compete throughout the University and with the World Campus but we need to be very smart in our approach. In order for Penn State Berks to continue to be successful, it will take a comprehensive approach which includes all aspects of the classroom experience, both one on one and on-line. The Chancellor also shared that enrollment at Penn State Berks has grown but that is not the case at a fair number of other Penn State campuses. Part of this is driven by the fact that there needs to be more sharing of resources. At the conclusion of the report, Senior Associate Dean Esqueda introduced Daonian Liu, who replaces Tricia Clark as the Director of the Center for Learning and Teaching, and Instructor of Information Sciences and Technology.

7. Motions from Committees

- Motion from the Executive Committee to Amend the Standing Rules of the Penn State **Berks Constitution** (Appendix A) – The Chair provided an overview concerning the discrepancy concerning the fact that the Student Life Committee chair also chairs the Student Facility Fee Committee. The Chair turned the floor over to the Student Senator who provided the rationale for the amendment. The Chair opened the floor for discussion. A question was raised as to who has jurisdiction over this. A set of guidelines was made previously by retired Director of Student Affairs, Dr. Blaine Steensland and Dr. Ken Miller of Penn State Behrend, but it did not outline who is the leadership of the committee. It was brought to the Chair's attention by current Director of Student Affairs (Teri Sabatelli) that the current chair of the Student Life Committee was not aware of those duties, and it was informal in nature. Since the Student Facility Fee Committee oversees a significant amount of money for allocation, it needs to be formalized going forward. Another question brought to the floor questioned the jurisdiction for the Senate to have the authority over a non-Senate standing committee. The Chair remarked that this was reviewed with Senate Parliamentarian, Dr. Mohamad Ansari, who informed this could go under the standing rules. A suggestion was made to change the language to read as follows: The chair of the Student Life Committee shall also Co-Chair the Student Facility Fee Committee. The Chair called for a motion to approve the change; a vote was called and the motion was approved. The Chair called for discussion on the amended motion. Another suggestion was made to add to the end of the statement, when requested. The Chair called for a motion to approve the amendment to the amendment; a vote was called and the motion was approved. The Chair called for discussion on the second amended motion. After much discussion, the Student Senator explained this is merely following tradition that has been followed over the years and the need for having it more formal in nature. The Chair called for a motion on the twice-amended changes; a vote was called and the motion was approved.
- Motion to Drop the Associate Degree Program in HM (Rationale: The Bachelor Degree has been added to the curriculum and the Associate Degree is therefore being phased out.)
 The Chair commented that an official document was not available for this motion, noting that this is more of a formalization of what has already transpired in Academic Affairs. The Chair called for a motion to approve. Senator Snyder requested having a document providing both background and rationale for this motion. The Chair called for a motion to table this until the next Senate meeting; a

vote was called and with 5 nays, *the motion to table was not approved*. The Chair commented there is a document but it was not available in time for the meeting.

8. Informational Reports – Informational Report on General Safety Concerns, Physical Facilities Review, and Sustainability Review (Appendix B)

9. New Legislative Business – The election of Senate Officers for the next academic year. The Chair called for additional nominations from the floor; hearing none, a motion was called to close nominations and was second. The Chair read aloud the slate of nominees forwarded by the Executive Committee. Dr. Mohamad Ansari nominated the following: Chair, Dr. Michael Bartolacci, and Vice-Chair, Dr. Mahdi Nasereddin; both were uncontested. The position of Secretary had two nominations: Dr. Robert Zambanini and Dr. Nathan Greenauer. The election of Secretary will be instated by electronic ballot and those results will be announced at the next Senate meeting. The Chair called for a vote to approve the nominations; a vote was called and the nominations were approved.

11. Comments for the Good of the Order

- A concern was raised as to the lack of discussion surrounding the vote that will be taking place tomorrow through University Faculty Senate on a report concerning health benefits. Specifically, costs between higher paid vs lower paid employees, costs of various medical plans, contribution rates, etc. Clarification was provided by Senator Nasareddin stating this report is an advisory report so there will be no vote. The Chair explained that many of the reports seen in their meetings are non-voting reports. The Chair remarked that he would like to begin sending out links to all shared reports that are more of an advisory nature in order to keep faculty informed. Senator Snyder commented that a lot of this has to do with the timing of when these reports come out and when our meetings are held; he would like to see these be more in sync with each other in order to have these concerns addressed. Several of the Senate Officers reiterated the importance for faculty to bring any concerns they may have to the attention of any Senate Officer.
- Secretary Zambanini wanted to thank all involved with Engineers Week, which took place at Penn State Berks a few weeks ago. Attendance was up in many of the activities from last year and comments from all were very positive.

Motion from the Academic Affairs Committee

The Academic Affairs Committee unanimously approved the dropping of the 2 HM (2 Year, Associate's Degree Hospitality Management) Program.

The committee brings the motion to drop this program to the Berks Senate. It needs no second since it is brought forth by the committee chair and needs only a vote from the senate.

<u>Rationale</u>: This program has been replaced by the 4 HM program and its termination was part of the agreement with the School of Hospitality Management to begin offering the 4 Year Bachelor's Degree in Hospitality Management.

INTERCOLLEGIATE ATHLETICS COMMITTEE

Minutes

The Intercollegiate Athletics Committee of the Berks Campus Senate met on Thursday, March 19, 2015 from 12 to 1:00 in Thun Library 145. Present were Ray Mazurek, Chair, Lisa Diebler, Berks Athletic Director, Bruce Hale, Faculty Athletic Representative, and David Sanford.

The focus of the meeting was the committee's review of progress in improving academic success support for student athletes. The discussion primarily focused on the Penn State Berks Faculty Athletics Representative Annual Report (attached) for Fall 2013-Spring 2014, prepared by Lisa Diebler. As noted in the report, most student athletes at Berks are successful students; however, some athletic teams struggle a bit more than others. Ms. Diebler also reported the following information, in which Berks Student-Athlete GPA is shown to be very similar to overall Berks student GPA:

The Athletics Department currently encourages student-athletes to work with the usual academic support services, such as the learning center.

The Committee also discussed Ms. Diebler's idea of creating a volunteer Faculty Mentor Program, in which faculty might volunteer to be a mentor to a team, making themselves available at a few team events in order to get to know and mentor students. Ms. Diebler reported that such mentor programs had been successful at other institutions, and the committee encourages her to explore setting this up at Berks. Bruce Hale also suggested, and the committee encouraged, the possibility of setting up a section of PSU-5 that might focus on study skills for student athletes. One such section might be targeted to those student athletes who seem most at risk.

Six (6) intercollegiate teams earned a Fall 2013 team GPA of 3.00 or above: Men's Cross Country, Women's Cross Country, Men's Golf, Women's Soccer, Women's Tennis, and Women's Volleyball. Six (6) intercollegiate teams earned a Spring 2014 team GPA of 3.00 or above: Women's Cross Country, Men's Golf, Women's Soccer, Softball, Women's Tennis, and Women's Volleyball. Six (6) intercollegiate teams earned a 2013-2014 team GPA of 3.00 or above: Men's Cross Country, Women's Cross Country, Men's Golf, Women's Soccer, Women's Tennis, and Women's Volleyball.

Report on Faculty Salaries, 2014

<u>Penn State Berks Senate</u> <u>Strategic Planning and Budget Committee</u>

Summary:

The following report on faculty salaries is provided by the Strategic Planning and Budget Committee. Faculty salary information is presented in comparison to other PSU colleges which we regard as our peer institutions within the Penn State system (Erie (Behrend), Harrisburg (Capital), Abington, Altoona, and the University College).

Here is the comparison of salaries by division/rank to peer institutions:

Although future salary improvement efforts should focus on faculty achievement, over the years there has been a downward trend of faculty salaries at Berks compared to the other peer campuses. In comparison to last year, these rankings have remained fairly stable and place Berks at or near the lowest median salaries in the Associate and Assistant levels. In the HASS Division, the Associate Professor rank is currently 10th out of 11, the Associate Professor rank in the EBC Division is 8th out of 11, and the Associate Professor rank in the SCIENCE Division is 8th out of 8. While we are pleased to note that the salaries for Full Professors at Berks fall more centrally in comparison to the peer campuses, we would like to see that placement extended across all levels. We commend the Berks College administration for its efforts thus far to improve faculty salaries relative to similar PSU colleges, and would encourage this continued commitment to financially support faculty at all ranks compared to PSU colleges and PSU University Park.

Also, there is a concern that part-time faculty salary information is not included in the annual report by the University Faculty Senate, since many courses are taught by part-time faculty. In this era of transparency at Penn State, perhaps this information should be made available.

This report is based primarily on Table 14 of that overall data, which focuses on faculty from PSU Berks and other non-UP locations. **Drs. Abdullah Konak, Jianbing Qi and Hartono Tjoe summarized this data as graphs and charts for this report. Thank you!**

For each category, <u>data given are the median salaries</u> (mid-range salary of the group). This helps to avoid variation caused by one or two exceptionally high (or low) salaries.


It must be remembered that this data is problematic in several ways, which make accurate comparisons difficult:

- Salaries of small groups of faculty are not reported, since this would make it too easy to identify individual faculty salaries. In some cases, low numbers mean data is not given for a particular rank (for example, full Professors in Science at Abington and the University College).
- Due to low numbers, salaries are reported only at the Division level. A breakdown by discipline is not given.
- Small groups also make it possible for one or two individuals to greatly change a group's
 reported median salary. For example, if two faculty members in a group of four retire
 and are replaced by new hires earning lower salaries, this could greatly lower the group
 average.
- Divisions contain different disciplines at different locations. This affects comparisons for all three of our divisions. In the case of our EBC division (Engineering, Business and Computing), other locations often split business and engineering, and thus are not fully comparable. Similarly, our HASS division is compared to divisions including "Education and Human Development" (Altoona) and "English" (University College) as well as others which, like HASS, combine Humanities and Social Sciences. Our Science division, meanwhile, is compared to units such as Abington's "Science and Engineering" division and the University College's "Math" faculty.


Despite these issues, we present the following charts and graphs as the best representation of the salary data we have available. In each case the number of faculty at each rank is given (N), as is the average number of years in rank for that group (Y). (Generally, we expect that more years in rank would mean higher salary.)

The three divisions of Berks College are presented below, with comparisons to peer institutions.


Division of Science – Comparison of Salary by Rank




Division of Science – Comparison of Salary by Rank (continued)







Informational Report from the Academic Affairs Committee Regalia Decorations for Campus Service Organizations April 20, 2015

Rationale and Discussion

The Executive Committee charged the Faculty Affairs Committee to rule on an inquiry from the Office of Student Affairs. A group of Campus Service Organizations (including Lion Ambassadors and the Veterans Club) requested permission for their graduating members to wear club-specific decorations during commencement. The committee discussed (via electronic means) the merits of the request. The majority of the Academic Affairs Committee agreed that commencement is an academic ceremony rich in history and tradition, with academic regalia being one of those traditions. The purpose of commencement is to recognize and honor academic achievement.

Conclusion

The Academic Affairs Committee has decided to uphold the current policy on regalia; the request for the use of non-academic distinctions during commencement is denied.

Recommendations

The Office of Student Life holds a ceremony every year celebrating student leadership and campus involvement, where student leaders, including Lion Ambassadors, are personally recognized. The Committee encourages student organizations to inquire with Student Life to seek recognition during this particular ceremony.
